WA FBLA is proud to honor Roger Beck as the WBEA Outstanding CTSO Adviser of the Year! Thank you for your many years of service to FBLA, to your community, and to your students!

Roger Beck holds a Bachelors of Arts in Business Education from Eastern Washington University. He has been teaching for 50 years and has taught in the St John School District his entire career.

He has been a member of Washington State Business Education Association (WSBEA) for 47 years and has served on the WSBEA Board for 14 years. In addition to WSBEA, Roger is also a member of WBEA, NBEA, and WA-ACTE.

While serving as an FBLA Adviser, many students competed at the national conference. Roger always ensured that students were also able to learn about the hosting city. Students visited local sites and were able to bond as a chapter over the shared experiences. At the state level, Roger proctored events and mentored not only his students, but all FBLA members. In 2018 Roger received the Washington State FBLA Adviser of the Year Award.
