## **OSPI BULLETIN 073-20—CTSOs STILL REQUIRED!**

RE: Career & Technical Education Guidance for 2020-21

Summary: The purpose of this bulletin is to clarify requirements to implement approved Career and Technical Education (CTE) courses during school year 2020–21. While the instructional approach for the 2020–21 school year may be different than the in-person model commonly required to provide CTE coursework, the requirements for courses that receive CTE enhanced funding will not change.

## **SUPER SWEEPS IS OPEN**

Super Sweeps is now open. Super Sweeps is the first part of the Chapter Challenge. Chapters choose ten activities from a variety of projects designed to help chapters recruit and retain members. Activities range from planning a recruitment drive to creating a Membership Committee.

### ***Incentives:***

All chapter advisers registering their chapter for Super Sweeps will receive FBLA-PBL #Super Sweeps digital social media photo frames to distribute to all of the members in their chapter.

In addition, all chapters completing Super Sweeps will receive a certificate of recognition, ribbons for their delegates that attend NLC, and be placed into a drawing for a special Aspire to Lead Recruitment Kit (box) perfect for promoting FBLA at an Open House, in your classroom, at a Club Recruitment Fair, or virtual Officer Broadcasts and monthly updates. We will be giving 10 of these boxes away for Super Sweeps during the first week of November. Each box is worth approximately \$1,000. Some of items include:
